WHEREAS, This Office is in receipt of your application for grant of Consent to establish for Construction of IT Park Project at under Section 25 of the Water (Prevention & Control of Pollution) Act. 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008.

ANDWHEREAS, MPC Board has issued Show Cause Notice for refusal of consent to establish and stop work vide letter No. MPCB/ RO(HQ)/ Infra/ SCN/ B-4562 dated: 15/10/2013, for starting activities without obtaining prior Consent to Establish from the Board, Environment clearance and Coastal Regulation Zone Clearance (CRZ Clearance) from competent authority.

WEEREAS, you have submitted reply to show cause notice for refusal of consent to establish at project location and your reply is silent in respect of applicability of CRZ clearance to your IT park project.

ANDWHEREAS, Your application for grant of consent to establish for IT Park Project along with your reply dated: 06/12/2013 was discussed in Consent Committee meeting of the Board dated: 27/12/2013 and It was felt that firstly the reply is not in consonance with the definition of effective steps a per MoEF Office Memorandum and secondly, the reply is silent about CRZ clearance. In view of non-satisfactory reply to the SCN, it was decided to issue final rerusal and also intimate to MCZMA separately.

In view of the aforesaid non compliance, your application for grant of Consent to establish is nereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
