

WHEREAS, this office was in receipt of your application for grant of Consent to operate with expansion under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

AND WHEREAS, Your case was discussed in the consent committee meeting held on 12.02.2014. In this meeting it was decided to issue refusal of consent for expansion as it is violated RRZ Policy, 2009. Also it was decided to issue Show cause notice for plain renewal and stop work.

In view of above, your application for grant of Consent to operate for expansion is hereby **refused** under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008 and you are directed not to take any steps towards manufacturing the additional / expansion production quantity.
