CONDITIONS UNDER AIR ACT : 5.

The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards :

The unit must implement the following pollution control measures:

- 1. Dust containment cum suppression system for the equipments viz. crusher, Sieves, conveyor belts, any other source of particulate matter.
- 2. Growing of a green belt along periphery.
- 3. Regular cleaning & wetting of the ground within premises.
- 4. Construction of metalled roads within premises.
- 5. Construction of wind breaking walls.

Standards for Emission of Air Pollution:-

- i) The Suspended particulate matter measured between 3 meters to 10 meters from any process equipments of stone crushing unitshall not exceed 600 microgram/ m³.

- The applicant shall provide ports in the chimney (s) and facilities such as (iv) ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted /displayed to facilitate identification.
- The industry shall take adequate measures for control of noise levels from its (v) own sources within the premises so as to maintain ambient air quality standard in respect of noise to less than 75 dB(A) during day time and 70 dB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.
- (vi) Other Conditions
 - 1) The industry should not cause any nuisance in surrounding area.
 - 2) The industry should monitor stack emissions and ambient air quality

- 6. CONDITIONS UNDER HAZARDOUS WASTE (MH &TM) RULES, 2008:

(i) The applicant shall handle hazardous waste as specified below:-

Whenever due to any accident or other unforeseen act or even, such emissions occur pris apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.

- General conditions: 8.
 - The applicant shall bring minimum 33% of the available open land under green (i) coverage/ plantation. The applicant shall submit a yearly statement by 30th September every year on available open plot area, no. of trees surviving as on 31st March of the year and no. of trees planted by September end.
 - (ii) The applicant shall provide for an alternate electric power source sufficient to operate all pollution control facilities installed by he applicant and operate the same in case of power failure to maintain compliance with the terms and conditions of the consent. In the absence of same, the applicant shall stop, reduce or otherwise, control production to abide by terms & conditions of this consent regarding pollution levels.

- (iii) The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent. The applicant shall not change or alter quantity, quality, the rate of discharge, temperature or the mode of the effluent/ emissions or hazardous wastes or control equipments provided for without previous written permission of the Board.
- (iv) The firm shall submit MPCB, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992 before 30th September every year.
- (v) The applicant shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained. The applicant shall also submit a comparative statement of designed power and chemical consumptions vis-a vis actual power and chemical consumption along with Environmental statement.
- (vi) Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers down- stream of the terminal manholes. No effluent shall find its way other than in designed and provided collection system. Neither, storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.
- (vii) The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous wastes to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf. An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.

 (viii) The industry shall ensure that fugitive emissions from the activity are controlled so as to maintain clean and safe environment in and around the factory premises.
- 9. This consent is issued as per the River Distance Certificate issued by the irrigation department vide letter No:6464 dated 28.10.2013 submitted by industry vide letter dated 6.11.2013.As per the said certificate the Nag River Distance from the said unit is 1085 meters.

The applicant shall not operate the plant after 28.02.2015 and submit the irrevocable bank guarantee of RS. 50,000/- drawn in favour of Regional Officer, MPCB Nagpur within 15 days valid for the period up to 30.06.2015 towards compliance of the same if the plant found in operation after 28.02.2015 ,the Board will forfiet the BG of Rs.50,000/-& initiate the legal action as deemed fit.
- 11. This Board reserves the fight to amend or add any conditions in this consent and the same shall be binding on the Applicant.
- 12. The total capital investment of industry is Rs.41.8/- Lakhs.
