ANDWHEREAS, MPC Board has issued Show Cause Notice for refusal of consent to establish vide letter No. MPCB/ RO(HQ)/ Infra/ B-5783 dated 30/12/2013 since you have not obtained Environmental Clearance and proposed location of MSW seems to be in NDZ, as distance is only 300 mtrs. and hence not complied with RRZ, Policy, 2009.


ANDWHEREAS, You are not submitted reply to show cause notice for refusal of consent to establish issued by the Board. This shows your negligent attitude towards Environmental aspects.

ANDWHEREAS, your application was put up before Consent Committee Meeting<sub>2</sub> of the Board held on 24/01/2014 and It was decided to issue Refusal of consent for not submitting the reply of Show Cause Notice in spite of providing adequate time to reply to the Applicant.

In view of the aforesaid non compliance, your application for grant of Consent to Establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
