

We refer to application for grant of Consent u/s 25/26 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management. Handling and Trans -boundary Movement) Rules 2008.

AND WHEREAS, Board office had issued Show Cause Notice vide letter dated 07/01/2014, as the industry has not upgraded effluent treatment plant and Air pollution control system. Accordingly you have submitted your reply vide letter referred No. 3 above. AND WHEREAS, compliance verification report submitted by Sub-Regional Officer Aurangabad-2 vide e-mail dtd. 13.03.2014. AND WHEREAS your application and present status of compliance of pollution control system was discussed in Consent Committee meeting of the Board held on 13/03/2014 and decided to issue refusal of renewal of consent.

In view of the aforesaid non compliance, your application for grant of renewal of consent is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
