WHEREAS, This Office is in receipt of your application for grant of Consent to Establish for construction of Residential Project at Ms. Ramnath Infraproject Pvt. Ltd, S. No 191/1,2,3,4 & 181/1A, P.H.No.18 Mauza Pavanagon, Tehsil Kamptee, Dist. Nagpur, under Section 25 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 & under Rule 5 of the Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2008.

ANDWHEREAS, you have started your construction activities having total Construction Built up Area of 31,324.0 Sq. mtrs without obtaining prior Environment Clearance from the competent Authority as per Environment Impact Assessment Notification Dated 14/09/2006 and Consent to Establish from the Board.

ANDWHEREAS Board office had issued e-mail about plan showing STP & MSW plant location from the HFL of the river. You have submitted reply along with plan showing STP and MSW plant from the river. As per submission MSW plant located 200mtrs from HFL of Nag River.

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 18/03/2014 and it has been decided to issue refusal of Consent to establish as distance of MSW plant from HFL of Nag River is only 200 mtrs.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
