WHEREAS, This Office is in receipt of your application for grant of Consent to Establish for construction of residential project at S. No. 44, Andhawali, Nashik under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008.

AND WHEREAS, While scrutinizing the application for Grant of Consent to Establish, it was observed that, you have started construction work without obtaining Consent to Establish from the Board and Environmental Clearance from Competent authority hence Board has issued show cause notice with stop work direction vide No. MPCB/RO(HQ)/Infra/SCN/b-1999 dated 22/4/2013.

AND WHEREAS, The case was discussed in Consent Committee Meeting of the Board dated 24/2/2014 and it was decided to obtain verification report from Regional office, Nashik regarding confirmation of stop work or not and as per verification report of construction project submitted by Sub Regional Office, Nashik dated 25/3/2014, you have not stopped the construction activity at project site in spite of issuance of stop work direction by the Board. This shows your negligent attitude towards Environmental aspects.

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 10/4/2014 and it has been decided to issue final refusal of consent to establish for Starting construction without obtaining Consent to Establish from Board and Environmental Clearance from Competent authority and continued the construction activity in spite of issuing stop work direction by the Board

In view of the aforesaid non compliance, your application for grant of Consent to Establish and Operate is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
