
WHEREAS, Board has granted consent to operate to your unit vide reference no.2. Now you have applied for grant of renewal of consent to operate under the provisions of Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management and Handling) Amendment Rules, 2008.

**AND WHEREAS, Sub Regional Officer Pune- II has reported that Industry has not discarded incinerator as per earlier consent condition and not submitted justification about increase in capital investment. Also not submitted reply to the letter issued by RO Pune. Also not submitted reply to show cause notice.**

AND WHEREAS, Your case was discussed in the consent committee meeting held on 10.04.2014. In this meeting it was decided to refuse the renewal of consent to operate as industry has failed to discard incinerator as per previous consent condition and failed to reply for increase in capital investment. Also failed to submit reply to show cause notice.

In view of above, your application for grant of renewal of Consent to operate is hereby **refused** under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.
