WHEREAS, This Office is in receipt of your application for grant of Consent to Establish for construction of Infotel Broadband Project at Kh. No. 30/1,30/3,32/1,32/3, 32/4,33,34/1, 34/2,101/1 Mouza Rahadi Tal Mouda, Dist-Nagpur under Section 25 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008.

AND WHEREAS, Officer of the Sub-regional officer Nagpur-II has visited your site on dated 15/10/2013 and reported that you have started your construction activities and completed 15 to 20% of construction work without obtaining consent to Establish from board for IT & ITES activity project. AND WHEREAS, as per submission of application form you have attached site map which is adjacent to the Kanhan River but distance certificate submitted by you is 2.24 Km from river.

ANDWHEREAS Board office had issued Directions u/s 33 A of the Water Act,1974 & under Section 31 A of the Air Act,1981on dated 11/02/2014 . You have failed to submit reply to the said direction issued by the Board.

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 29/04/2014 and it has been decided to issue refusal of Consent to Establish for non submission of reply to directions issued by the Board.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
