WHEREAS, This Office is in receipt of your application for grant of Consent to Operate for construction of Residential Project at S. No. 16/2 Kondhwa, Tal: Haveli, Dist: Pune under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008.


AND WHEREAS, Sub-regional officer Pune-II, has visited your site and reported that you have handed over 6 buildings to buyers without obtaining consent to operate from Board, also you have not submitted Bank Guarantee of Rs. 5 lakh as per Consent to establish condition No 17.

ANDWHEREAS Board office had issued Directions u/s 33 A of the Water Act, 1974 & under Section 31 A of the Air Act, 1981 on dated 14/02/2014 .You have failed to submit reply to the said direction issued by the Board. This shows your negligent attitude towards Environmental aspects.

AND WHEREAS, your application was put up before Consent Committee Meeting of the Board held on 29/04/2014 and it has been decided to issue refusal of Consent to operate for non submission of reply to directions issued by the Board.

THEREFORE, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
