WHEREAS, This Office is in receipt of your application for Grant of Consent to 1st Operate (Part-I) for construction of redevelopment project at CTS No.303 C & 303 A/2 of village Bhandup at Datta Mandir Road, Bhandup(W), Mumbai-78 under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008.

ANDWHEREAS, As per Consent Committee Meeting of the Board dated 18/3/2014, Board has issued Show Cause Notice under the Provisions of the Water (Prevention & Control of pollution) Act, 1974, and Air (Prevention & Control of Pollution) Act, 1981 on 28/3/2014 since Consent to Establish and Environmental Clearance is not valid.


ANDWHEREAS, your reply of show Cause notice was discussed in Consent Committee Meeting of the Board dated 29/4/2014 and It was decided to issue final refusal of consent to 1st operate as Project Proponent has not obtained revalidated Environmental Clearance from Competent authority.
