WHEREAS, This Office is in receipt of your application for grant of Consent to Establish for construction of industrial gala at Plot No.K-12, MIDC Taloja, Panvel under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008.

ANDWHEREAS, MPC Board has issued Show Cause Notice for refusal of Consent to Establish vide letter No. MPCB/ RO(HQ)/ Infra/ SCN/ B-1729 dated 8/5/2014, as Project Proponent has failed to submit distance certificate from Executive Engineer, Irrigation Department, details regarding proposed number of galas and infrastructure facilities proposed in pollution angle.


ANDWHEREAS, You have not submitted reply to show cause notice for refusal of Consent to Establish dated 8/5/2014.

ANDWHEREAS, Your application was discussed in Consent Committee meeting of the Board dated 14/7/2014 and it was decided to issue Refusal of consent to Establish, as project proponent has failed to submit reply to show cause notice dated 8/5/2014, in spite of providing sufficient time to reply and also for non submission of distance certificate from Executive Engineer, Irrigation Department, details regarding number of galas proposed and infrastructure facilities proposed in pollution angle.

In view of the aforesaid non compliance, your application for grant of Consent to Establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
