Sub – Refusal of Consent under section 27 of water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

With reference to above subject, this office has received your application for Consent to Establish & Operate under Section 25 & 26 of the Water (Prevention and Control of Pollution) Act, 1974; Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Authorization under Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008 and Amendments thereto.

AND WHEREAS, it has been observed that you have not submitted distance certificate of Executive Engineer, Irrigation Department from River Mutha.

ANDWHEREAS, your application again put up before Consent Committee Meeting of the Board held on 14/07/2014 and it has been decided to issue refusal of Consent to Establish as project proponent has failed to submit river distance certificate from Executive Engineer, Irrigation Department.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
