
ANDWHEREAS, MPC Board has issued letter vide No. MPCB/RO(HQ)/B-3590, dated 13/08/2013 since you have not submitted architect plan showing distance of STP and MSW plant from HFL of the river, as per RRZ committee meeting decision dtd.07/06/2013.

ANDWHEREAS, You have not submitted reply to letter issued by the Board. This shows your negligent attitude towards Environmental aspects.

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 14/07/2014 and It was decided to issue Refusal of consent to establish in spite of providing adequate time to reply and for not submitting architect plan showing distance of STP and MSW plant from HFL of the river, as per RRZ committee meeting decision dtd.07/06/2013

In view of the aforesaid non compliance, your application for grant of Consent to Establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
