ANDWHEREAS, your application along with reply received on 10/06/2014 was put up before Consent Committee Meeting of the Board held on 14/07/2014 and it has been decided to issue refusal of Consent to Establish as project proponent has applied for environment clearance for total BUA 30,748.01 sq.mt and carried out constructions without C to E and EC.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.
