WHEREAS, This Office is in receipt of your application for Grant of Consent to Establish for construction of residential Project at **at survey no: 22/3 CTS No. 4688, Waghire, Pimpri, Tal. Maval, Dist: Pune.** under Section 25 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008

ANDWHEREAS, MPC Board has issued Show Cause Notice for refusal of consent to establish vide letter No. MPCB/ RO(HQ)/ Infra/ B-2044 dated 30/05/2014 since you have started construction activity without obtaining prior Consent to Establish from the Board & Environment clearance from competent authority.

ANDWHEREAS, You have not submitted reply to show cause notice for refusal of consent to establish issued by the Board. This shows your negligent attitude towards Environmental aspects.

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 30/07/2014 and It was decided to issue Refusal of consent to establish in spite of providing adequate time to reply and for starting construction activity without obtaining prior Consent to Establish from the Board & Environment clearance from competent authority.

In view of the aforesaid non compliance, your application for grant of Consent to Establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
