WHEREAS, you have made an application for grant of Consent to Establish under Section 25 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Tran boundary Movement) Rules, 2008 for construction of the Educational Institute & Residential Hostel project at S.No. 38/1B, 44/2A 2B, 44/2C, 44/2B, 45/1A, 45/1B, 45/1C, 45/1D, 45/1E, 47/4, 47/5, 48/1, 53/1B, 53/12, Opposite Solapur University, Kegaon, Sholapur.

AND WHEREAS, Officer of the Sub-regional officer Solapur, had visited your site on dated 11/02/2014 and observed that you have started construction of 8 Institute Buildings and 7 Nos. of residential buildings completed and partly commissioned. The construction work of other buildings is in Progress.


AND WHEREAS Board office had issued Directions u/s 33 A of the Water Act, 1974 & under Section 31 A of the Air Act, 1981 on dated 26/06/2014 .You has failed to submit reply to the said direction issued by the Board.

ANDWHEREAS, Again your application was put up before Consent Committee Meeting of the Board held on 24/09/2014 and it has been decided to issue refusal of Consent to establish as applicant has started construction activity without consent to establish and Environment Clearance. And also failed to submit reply to the said direction issued by the Board.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
