WHEREAS, you have made an application for grant of Renewal of Consent to Operate under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008 for hotel activity at CTS No.1511/A and B 1511/1103,Malad Mudh Road,Malad(W).

ANDWHEREAS, MPC Board has issued Show Cause Notice for refusal of Renewal of Consent to Operate vide letter No. MPCB/ RO(HQ)/CC/ B-3370 dated 20/08/2014 since you have not submitted previous Bank Guarantee of Rs.5 lakhs as per consent condition no.9 and also not provided Effluent Treatment Plant for treatment of effluent.

ANDWHEREAS, You are not submitted reply to show cause notice for refusal of Renewal of Consent to Operate issued by the Board. This shows your negligent attitude towards Environmental aspects.

ANDWHEREAS, your application was put up before Consent Committee Meeting of the Board held on 05/11/2014 and It was decided to issue Refusal of consent for not submitting the reply of Show Cause Notice in spite of providing adequate time to reply to the Applicant.

In view of the aforesaid non compliance, your application for grant of Renewal of Consent to Operate is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981
