Consent to operate under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization/Renewal of Authorization under Rule 5 of the Hazardous Waste (Management, Handling & Transboundry Movement) Rules 2008 and Amendment Rules, CONSENT is hereby granted to

located in the area declared under the provisions of the Water Act, Air act and Authorization under the provisions of HW(MH & TM) Rules and amendments thereto subject to the provisions of the Act and the Rules and the Orders that may be made further and subject to the following terms and conditions:

1. The Consent to Operate is granted for a period up to: 31.12.2018.

3. CONDITIONS UNDER WATER ACT:

(i) The daily quantity of trade effluent from the factory shall not exceed 2.9 m³. (ii) The daily quantity of sewage effluent from the factory shall not exceed 0.8 m³.

(v) Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same sly so as to achieve the quality of treated effluent to the following standards.

(viii) Other conditions: The industry shall monitor effluent quality regularly.

The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for (iv) use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/ displayed to facilitate identification.

The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standard in respect of noise to (\mathbf{v}) less than 75 dB(A) during day time and 70 dB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.

Whenever due to any accident or release of pases or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such 7. information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body and the production process should be stopped by taking all necessary safety measures. The industry shall also monitor the emissions and ensure that the emissions do not cause any harm or nuisance in the surrounding. The industry should not restart the process without permission of the Board and other statutory organizations as require under the law.

General Condition 8.

- a. Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by treating the room acoustically.

from other Govt. agencies as may deemed fit necessary. 9.

- If CETP does not work for achieving standards and problem of pollution occurs, industry should voluntarily stop the production or total effluent should be reused. 10.
- This consent is issued as per the delegation of powers to HOD's vide Board Office Order 11. No. 31/2013 dtd. 01/03/2013.
- The industry shall also comply with the Industry specific standards notified under 12. Environment Protection Act.
- Industry shall re-start production activity after obtaining written permission of Regional Officer about operational status of pollution Control systems. 13.
