Sub: Refusal of consent under Section 27 of the Water (Prevention and Control of Pollution) Act 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act 1981.

Ref: 1. Your application for consent to establish (expansion) received through Sub-Regional Office MPCB Mahad.

This office is in receipt of your application for Amendment in consent with change in product mix, under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management Handling & Transboundary Movement) Rules, 2008.

The application was placed before Consent Committee of the Board in its meeting held on 26/12/2014, the substitution quantities you have applied under change in product mix were not within the previously granted overall consented limits and was not satisfying the contents of product mix circular dtd-14/12/2006 hence as per the decision of Consent Committee, Show Cause Notice was issued vide letter ref (3) above. This office has received your reply to the Show Cause Notice issued vide ref (4) above requesting to consider the revised proposal for change in product mix.

The case was resubmitted with your reply before Consent Committee of the Boards in its meeting held on 10/04/2015, and It was decided not to consider your request for amendment with change in product mix as there is increase in by-Products quantity and does not satisfy product mix circular dtd-14/12/2006 issued by MoEF, Government of India.

In view of this, your application for amendment in consent with change in product mix consent is refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 due to increase in production quantity in proposed change in product mix. If you feel so, you may go in appeal before Appellate Authority within one month's period & shall not take any effective steps towards expansion of production without Consent from Board and shall restrict the production quantity as per the existing consent.
