- 8. This consent should not be construed as exemption from obtaining necessary NOC/permission from any other Government authorities.
- 9. The existing pollution load of the industry shall not increase due to proposed change in product-mix.
- 10. If CETP cannot operate efficiently and problem of pollution occurs, industry should voluntarily stop the production or total effluent should be reused.
- 11. The applicant shall not carry out any excess production or produce new products without consent of the Board and without an Environment Clearance wherever it requires.

- 12. The applicant shall not increase the water consumption and effluent quantity prescribed in the Consent. Also, shall not make use of any other water supply from the unauthorized sources like tanker and borewell etc.
- 13. The applicant shall not discharge any effluent in any other source other than the CETP sewerage drain for further treatment and disposal.
- 14. The applicant shall properly collect, transport & regularly dispose off the hazardous waste to CHWTSDF, in compliance of the Hazardous Wastes (Management, Handling & Transboundry Movement) Rules, 2008 and keep proper manifest thereof.
- 15. The applicant shall provide lock & key arrangement for treated industrial effluent.

- The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/displayed to
- Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be
- The applicant shall provide an alternate electric power source sufficient to operate all pollution control facilities installed to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms and conditions of this consent.
- 7) The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection)
