WHEREAS Board has granted Consent to Operate to your unit vide above referred letter at sr. no. 1 with certain terms and conditions therein which was valid up to 30.11.2014.

AND WHEREAS you have applied for grant of Renewal of Consent to Operate, under the provisions of Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundry Movement) Rules 2008.

AND WHEREAS, your application for grant of Renewal of Consent to Operate was placed before CAC meeting held on 10.03.2015 and during meeting it was decided to

issue Show Cause Notice for refusal of Renewal of Consent to Operate, Closure of manufacturing activity and forfeiture of BG as you have not provided wet scrubber to the boilers within stipulated time, also you have failed to comply the condition of reduce waste water generation 100 litrs. per ton of cane crushed, treated effluent is partly discharged into the adjacent nallah, JVS results of treated effluent and stack monitoring are not meeting the Consented limits.


AND WHEREAS, as per the decision of CAC, Show Cause Notice was issued vide dtd. 07.04.2015. AND WHEREAS, you have submitted your reply vide letter dtd. 16.04.2015.

AND WHEREAS, Sub-Regional Officer Satara has submitted compliance report of the SCN issued by the Board vide dtd. 29.05.2015 and reported that you have not provided wet scrubber till date.

AND WHEREAS your application was resubmitted before Consent Appraisal Committee meeting held on 21.07.2015 alongwith the reply submitted by you and compliance report submitted by the SRO, Satara, during meeting it was decided to issue final refusal of Renewal of Consent to Operate as you have not up-graded the existing air pollution control system in stipulated time period given in the previous Consent to Operate and violated the provisions of Water (P & CP) Act, 1974 and Air (P & CP) Act, 1981.

In view of the above, your application for grant of Consent to Establish for expansion is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refused order.
