WHEREAS you have applied for grant of Consent to Establish for proposed Distillery unit, under the provisions of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules 2008.

AND WHEREAS, your application for grant of Consent to Establish was placed before CAC meeting held on 28.11.2014 and during meeting it was decided to issue Show Cause Notice for refusal of Consent to Establish due to non submission of reply to letter issued by the Sub-Regional Officer, Solapur, non submission of correct capacity of the distillery, non submission of details regarding provision of proposed treatment and disposal of spent wash, non submission details of proposed land for bio-composting, non submission of proper water budget.


AND WHEREAS, as per the decision of CAC, Show Cause Notice was issued vide dtd. 26.12.2014.

AND WHEREAS, you have failed to submit reply to the Show Cause Notice issued by the Board till to date.

AND WHEREAS your application was resubmitted before Consent Appraisal Committee meeting held on 21.07.2015, during meeting it was decided to issue Final refusal for Consent to Establish as you have failed to submit the reply to the Show Cause Notice for Refusal of Consent to Establish issued by the Board vide dated 26.12.2014.

In view of the above, your application for grant of Consent to Establish for Distillery is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refused order.
