WHEREAS you have applied for grant of Consent to Establish for expansion, under the provisions of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundry Movement) Rules 2008.

AND WHEREAS, your application for grant of Consent to Establish for expansion was placed before CAC meeting held on 14.05.2015 and during meeting it was decided to issue Show Cause Notice for refusal of Consent to Establish for expansion as you have started work of expansion without obtaining Consent to Establish form the Board. Also land available for disposal of trade effluent after expansion is inadequate.

AND WHEREAS, as per the decision of CAC, Show Cause Notice was issued vide dtd. 26.05.2015. AND WHEREAS, you have submitted your reply vide letter dtd. 26.05.2015 and not submitted required information inrespect of land made available for the disposal of treated effluent.

AND WHEREAS your application was resubmitted before Consent Appraisal Committee meeting held on 21.07.2015 alongwith the reply submitted by you, during meeting it was decided to refuse the Consent to Establish for expansion as you have started the construction activity without obtaining Consent to Establish from the Board and violated the provisions of Water (P & CP) Act, 1974 and Air (P & CP) Act, 1981.

In view of the above, your application for grant of Consent to Establish for expansion is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refused order.
