3. CONDITIONS UNDER WATER ACT:

- (i) The daily quantity of trade effluent from the factory shall not exceed 1.5 m³.
- (ii) The daily quantity of sewage effluent from the factory shall not exceed 4.8 m³.
- (iii) Trade Effluent Treatment- The applicant shall operate comprehensive treatment system consisting of primary / secondary and/or tertiary treatment as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of the treated effluent to the following standards:

- (iv) Trade Effluent Disposal: The treated effluent shall be reused/recycle in the process to the maximum extent and remaining shall be sent to CETP Butibori for further treatment and disposal. There shall not be any discharge outside the factory premises.
 - (v) Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards.

The applicant shall regularly submit to the Board the returns of water consumption in the prescribed form and pay the Cess as specified under Section 3 of the said Act.

5. CONDITIONS UNDER AIR ACT :

- The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:
 - A) Control Equipment:

 1) Fume extraction system followed by scrubber provided to Phosphating section and any other source producing emissions shall be operated and maintained properly so as to achieve following air emission standards.
 - 2) Fume inhibitor shall be used continuously as anti vapor in acid section to bring down the gaseous emission and scrubber provided to pickling section should operate and maintain properly.
 - 3) Bag filters shall be provided to Short blasting section to control emissions.
 - 4) There shall not any secondary (fugitive) emissions.
 - B) Standards for Emissions of Air Pollutants:
 - (i) SPM/TPM Not to exceed 150 mg/Nm³
 (ii) So2 Not to exceed 12 mg/Nm³
 (iii) Acid Mist Not to exceed 35 mg/Nm³

- (iv) The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted /displayed to facilitate identification.
- (v) The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standard in respect of noise to less than 75 dB(A) during day time and 70 dB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.

1) The industry should not cause any nuisance in surrounding area.

2) The industry should monitor stack emissions and ambient air quality regularly.

(i) The applicant shall handle hazardous waste as specified below:-

(ii) The authorization is here by granted to operate a facility for collection, storage, transport & disposal of hazardous waste.

Whenever due to any accident or other unforeseen act or even, such emissions occur 7. or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.

General conditions: 8.

The applicant shall bring minimum 33% of the available open land under green coverage/ plantation. The applicant shall submit a yearly statement by 30th September every year on available open plot area, no. of trees surviving as on 31st March of the year and no. of trees planted by September end.

The applicant shall provide for an alternate electric power source sufficient to operate (ii) all pollution control facilities installed by he applicant and operate the same in case of power failure to maintain compliance with the terms and conditions of the consent. In the absence of same, the applicant shall stop, reduce or otherwise, control production to abide by terms & conditions of this consent regarding pollution levels.

The applicant shall make an application for renewal of the consent at least 60 (iii) days before the date of the expiry of the consent. The applicant shall not change or alter quantity, quality, the rate of discharge, temperature or the mode of the effluent/ emissions or hazardous wastes or control equipments provided for without previous written permission of the Board.

The firm shall submit MPCB, the Environmental Statement Report for the financial year (iv) ending 31st March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992 before 30th September every year.

The applicant shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained. The applicant shall also submit a comparative statement of designed power and chemical consumptions vis-a vis actual power and chemical consumption along with Environmental statement.

Separate drainage system shall be provided for collection of trade and sewage (vi) effluents. Terminal manholes shall be provided at the end of collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers down- stream of the terminal manholes. No effluent shall find its way other than in designed and provided collection system. Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.

The applicant shall provide facility for collection of environmental samples and samples (vii) of trade and sewage effluents, air emissions and hazardous wastes to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf. An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.

- (viii) The industry shall ensure that fugitive emissions from the activity are controlled so as to maintain clean and safe environment in and around the factory premises.
- (ix) The applicant shall maintain good housekeeping and take adequate measures for control of pollution from all sources so as not to cause nuisance to surrounding area / inhabitants.
- 9. This Board reserves the right to amend or add any conditions in this consent and the same shall be binding on the Applicant.
- 10. The applicant shall submit Bank Guarantees of Rs. 2.0 Lakhs (Extended Rs. 1.0 Lakhs + Fresh Rs. 1.0 Lakhs) towards O&M of Pollution Control system & compliance of consent condition for the period up to 31/05/2016 & submit the BG to RO-MPCB, Nagpur within 15-days.
- 12. The total capital investment of industry is Rs.16.03/- Crores.
