Schedule-IV

General Conditions:

- The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous waste to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf.
- 2) Industry should monitor effluent quality, stack emissions and ambient air quality monthly/quarterly.
- 3) The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/ displayed to facilitate identification.
- 4) Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.
- 5) The applicant shall provide an alternate electric power source sufficient to operate all pollution control facilities installed to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms and conditions of this consent.
- 6) The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992.
- The industry shall send used oil to reprocess/re refiners authorized by MPCB & the Hazardous Waste to CHWTSDF Butibori Nagpur as per the provision contain in the HW(MH&TM) Rules 2008.
- 8) The industry should comply with the Hazardous Waste (M,H& TM) Rules, 2008 and submit the Annual Returns as per Rule 5(6) & 22(2) of Hazarsous Waste (M,H & TM) Rules, 2008 for the preceding year April to March in Form-IV by 30th June of every year.
- 9) An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.
- The applicant shall obtain Consent to Operate from Maharashtra Pollution Control Board before actual commencement of the Unit/ Activity for proposed other units (in case of Consent to establish).
- The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent (in case of Renewal of consent).
- 12) Industry shall strictly comply with the Water (P&CP) Act, 1974, Air (P&CP) Act, 1981 and Environmental Protection Act, 1986 and industry specific standard under EP Rules 1986 which are available on MPCB website(<u>www.mpcb.gov.in</u>).
- 13) The industry shall constitute an Environmental cell with qualified staff/personnel/agency to see the day to day compliance of consent condition towards Environment Protection.
- 14) Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of the collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers downstream of the terminal manholes. No effluent shall find its way other than in designed and provided collection system.
- 15) Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.
- 16) The applicant shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained.

Fly ash shall be by transported through bunker having closed system, coal carrying conveyor belt shall be covered from all side with provision of water springing/spraying system properly.
- 32) The applicant shall Operate online opacity meter/continuous monitoring system for process stack emission analysis & same shall be directly connected to MPCB website http://mpcb.gov.in as well as to the respective Regional Office within 3 months period and operate the same regularly.
- 33) The applicant shall Operate four continuous automatic ambient air and micrometeorological monitoring station at location indicated by MPC Board to be set up and operate at its own cost for measurement of SO2, NOx and particulate matter. These CAAQMS shall also have necessary provision of networking to the Air Quality Monitoring network of MPCB.
- 34) They shall promote adoption of clean coal and clean power generation technologies.
- 35) General guidelines for handling, storage & safety of Chlorine cylinders & drums.
 - a) Chlorine gas units and cylinders shall be housed in separate rooms, easily accessible, close to the point of application and convenient for truck loading and safe container handling
 - b) The floor shall be flat and at least 150 mm above the surrounding ground and drainage shall be adequate. The height of the container room should be at least 4.0 m. Under no circumstances such units shall be housed in basement or below ground level since the chlorine gas is heavy and settles into depressions.
 - c) The floor shall be flat and at least 150 mm above the surrounding ground and drainage shall be adequate. The height of the container room should be at least 4.0 m. Under no circumstances such units shall be housed in basement or below ground level since the chlorine gas is heavy and settles into depressions.
 - d) The temperature in the installation room shall be within the range of +4 to + 40°C. The chlorine gas containers and chlorine gas pipes shall not be exposed to direct heat radiations and shall be protected from sun rays.
 - e) Electrical installations inside the chlorine gas rooms shall be limited to the absolute minimum required. While laying electrical wiring and fixtures adequate safety precautions shall be observed during their installation of ensuring safe use of electricity.
 - f) Chlorine gas containers shall not be bumped, dropped or rolled on the ground and no object shall be allowed to strike them with force.
 - g) Cylinders shall be stored vertically so that a leaking container, if found, can be removed with the least possible handling of others.
 - h) No other objects except chlorine gas storing containers shall be kept in the room.
 - i) All operating and storing rooms for chlorine gas appliances and containers shall be fire proof.
 - j) First aid box and eye wash fountain shall be provided outside chlorinator room.
 - k) Water shall never be applied to the chlorine leak to stop it, as it will only make it worse.
 - 1) When a chlorine leak occurs, the ventilation system should be operated immediately before any person enters the chlorination room.
 - m) In case of fire, the cylinders and drums containing chlorine shall be protected by spraying with water since the containers can burst at temperatures of over 70°C. Source of pressurized water shall be provided adjacent to the chlorination room.
 - n) No direct flame should be applied to the chlorine cylinder when heating becomes necessary.
