Whenever due to any accident or gas leakage or other unforeseen act or even, such emission occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Collector, Directorate of industry, Safety and Health, Police Station, fire Brigade, Directorate of Health services, Department of Explosives, Board and local Body the production process should be stopped by taking all necessary safety measures. Industry shall also monitor the emission and ensure that the emission do not cause any harm or nuisance in the surrounding. - vii. The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent.
- viii. The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992.
- ix. As inspection book shall be opened and made available to the Board's officers during their visit to the applicant.
- The applicant shall install a separate electric meter showing the consumption of х. energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained.
- xi. Separate drainage system shall be provided for collection of trade and sewage effluents. - xii. Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.
