AND WHEREAS, Board has refused consent under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981. AND WHEREAS, Sub Regional Officer, MPCB Kolhapur has reported that a) You have not provided Air Pollution Control system as per CREP norms. b) You have not provided the online monitoring system.

AND WHEREAS your application was discussed in Consent Committee meeting of the Board held on 03.02.2016 and decided to issue refusal of renewal of consent to operate and closure direction towards non compliances as non provision of Air Pollution Control System and non compliance as per CREP norms.

In view of the aforesaid non compliance, your application for grant of renewal of consent is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
