
**AND WHEREAS**, Board office had issued Show Cause Notice vide letter dated 04.12.2014, as a) The Effluent Treatment plant provided is inadequate b) You have not upgraded existing Air Pollution Control system by providing ESP/Bag Filters/ Wet Scrubber as per CREP Conditions c) You have not submitted the Bank Guarantees as per the previous consent condition. Accordingly you have submitted your reply vide letter referred at Sr. No. 3 above. **AND WHEREAS**, you have not submitted the time bound action plan for the provision of Air Pollution Control System as per CREP norms and also you have not submitted Bank Guarantees imposed in the consent.
