WHEREAS, you have applied for grant of renewal of consent under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

ANDWHEREAS, it is obligatory on your part to provide, operate and maintain Water and Air pollution control system properly.

ANDWHEREAS, Board official visited your industry and it is noted that you have installed and operating Phosphating process units without obtaining valid consent from Board and JVS monitoring reports levels parameters exceeds consented limits.

ANDWHEREAS, it is further observed and noted that as per previous consent conditions, you have not submitted, 1) BG of RS. 5.0 Lakhs for operating phosphating unit and additional furnace without adequate APC, 2) BG of Rs. 2.0 Lakhs towards submission of Board resolution.

ANDWHEREAS, Board has issued SCN for refusal vides dt: 27/10/2015 for the above non compliances and you have submitted reply vide dt: 29/11/2015 without latest stack monitoring reports.

ANDWHEREAS, It is noted that you have fails to address the issue after repeated communications which shows your negligent attitude towards Environment Protections.

In view of this, your application for grant of consent to Operate (Renewal) is hereby refused under Section-27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section-21 of the Air (Prevention and Control of Pollution) Act, 1981.
