WHEREAS, this office was in receipt of your application for grant of renewal of Consent to operate under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.


AND WHEREAS, your case was discussed in Consent Committee meeting of the Board held on 22.04.2015 and in this meeting it was decided to grant renewal of consent to operate with condition of submission of additional consent fees and submission of bank guarantee of Rs.5.0 Lakhs towards operation and maintenance of pollution control systems. The decision of consent committee meeting was communicated to the industry vide letter dated 28.04.2015.

AND WHEREAS, your case was again discussed in Consent Committee meeting of the Board held on 23.09.2015 and in this meeting it was decided to issue show cause notice for refusal of consent to operate as industry has not submitted additional consent fees and no communication was received from the industry. The show cause notice was issued to the industry on 13.10.2015.

AND WHEREAS, your case was again discussed in Consent Committee meeting of the Board held on 03.02.2016 and in this meeting it was decided to issue final refusal of renewal of consent to operate, as there is no communication from the industry regarding additional consent fees.

In view of above, your application for grant of renewal of Consent to operate is hereby **refused** under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.
