WHEREAS Board has granted Consent to Operate to your unit vide above referred letter at sr. no. 1 with certain terms and conditions therein which was valid up to 30.11.2014.

AND WHEREAS you have applied for grant of Renewal of Consent to Operate, under the provisions of Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundry Movement) Rules 2008.

AND WHEREAS, your application for grant of Renewal of Consent to Operate was placed before CAC meeting held on 27.08.2015 and during meeting it was decided to

issue Show Cause Notice for refusal of Renewal of Consent to Operate and to initiate legal action due to following non-compliance/ violations –

1. You have failed to submit required information asked by SRO vide letter dtd. 27.02.2015.
2. You have not submitted BG of Rs. 2/- Lakhs as per previous Consent condition.
3. During the visit of Board officials it was observed that you were discharging untreated effluent in factory premises near ETP.
4. You have not submitted CA certificate in the Board's prescribed format.
5. Analysis report of the trade effluent collected on 06.10.2014 is exceeding the Consented standards.


AND WHEREAS, as per the decision of CAC, Show Cause Notice was issued to you vide dtd. 19.09.2015.

AND WHEREAS, you have failed to submit reply to the Show Cause Notice issued by the Board.

AND WHEREAS your application was resubmitted before Consent Appraisal Committee meeting held on 22.03.2016, during meeting it was noted that industry has failed to comply the Consented conditions and not submitted reply to the SCN issued on 19.09.2015. Hence, it was decided to issue final Refusal of Renewal of Consent to Operate.

In view of the above, your application for grant of Renewal of Consent to Operate is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refused order.
