

**AND WHEREAS**, it has been decided in consent committee meeting dtd: 03/02/2016 to grant renewal of consent after submission of Bank Guarantees as per previous consent conditions imposed towards compliance consent conditions and CREP norms and requisite consent fees **AND WHEREAS** this office has issued letters referred above at Sr. No. 4 for submission of Bank Guarantees and requisite consent fees. You have paid only consent fees vide above ref at Sr. No. 5.

**AND WHEREAS**, your application was discussed in Consent Committee meeting of the Board held on 01/03/2015 and decided to issue final refusal of renewal of consent to operate as industry has not submitted Bank Guarantees as per previous consent conditions towards compliance of consent conditions; which shows your negligent attitude towards Environment Protection and compliance of consent conditions.

In view of the aforesaid non compliance, your application for grant of renewal of consent is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
