
AND WHEREAS, it has been decided in consent committee meeting dtd: 03/12/2015 to grant renewal of consent after submission of Bank Guarantees as per previous consent conditions imposed towards compliance consent conditions and CREP norms and analysis charges, **AND WHEREAS** this office has issued letters referred above at Sr. No. 4 for submission of Bank Guarantees and analysis charges. You have paid only analysis charges vide above ref. at Sr. 5.

AND WHEREAS, your application was discussed in Consent Committee meeting of the Board held on 01/03/2015 and decided to issue final refusal of renewal of consent to operate as industry has not submitted Bank Guarantees as per previous consent conditions towards compliance of consent conditions; which shows your negligent attitude towards Environment Protection and compliance of consent conditions.
