We refer to application for grant of Consent u/s 25 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling and Trans -boundary Movement) Rules 2008.


AND WHEREAS, Board office had issued Show Cause Notice vide letter dated 12.01.2016 as serious complaints made regarding poor performance and inadequate capacity of CETP-TEPS, existing CETP is having capacity of 25 MLD but not having capacity to collect, treat and dispose excess effluent of 20-25 MLD.

AND WHEREAS Maharashtra Pollution Control Board has issued Circular dated. 21.09.2016 in compliance with the orders passed by Hon'ble High Court for not to permit expansion / establishment of the industrial units in area where the associated CETPs are not complying with the required standards and where such CETPs do not have adequate hydraulic load capacities.

AND WHEREAS your application and your reply was discussed in Consent Committee meeting of the Board held on 23.03.2016 and decided to issue refusal of consent as Hon'ble NGT vide order dated. 02.07.2015 and Hon'ble High Court vide order dated. 13.08.2015 has passed order not to permit expansion / establishment of the industrial unit in the areas where the associated CETPs are not complying with required standards and where such CETPs don't have adequate hydraulic load capacities and TEPS CETP is non-complying CETP and there is no additional hydraulic load /capacity hence it was decided to issue final refusal of consent to establish.

In view of the aforesaid, your application for grant of consent to establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
