WHEREAS Board has granted Consent to Operate to your unit vide above referred letter at sr. no. 1 with certain terms and conditions therein which was valid up to 31.08.2014.

AND WHEREAS you have applied for grant of Renewal of Consent to Operate, under the provisions of Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules 2008.

AND WHEREAS, Regional Officer, Kolhapur had issued Interim Directions to your unit vide under reference no. 3.

AND WHEREAS, your case has discussed in the Consent Appraisal Committee meeting held on 24.02.2015 alongwith proposal to initiate action submitted by the Regional Officer, Kolhapur and it was decide to issue SCN for refusal of Renewal of Consent to

Operate & Closure of manufacturing activity due to following non-compliances -

- 1) You have failed to comply the Interim Directions issued by RO Kolhapur.
- 2) You have failed to provide compost yard as per CREP norms.
- 3) You have failed to revamp the second digester & commission the same on or before 30.10.2014 & not start second digester.
- 4) You have failed to carry out composting on the pacca compost yard.
- 5) You have failed to scrap all the kaccha lagoons.
- 6) You have failed to submit time bound program with bar chart to Sub-Regional/Regional Office.
- 7) You have failed to submit the BG as per previous Consent condition thereby violated the Consent conditions.

AND WHEREAS, as per the decision of CAC, Show Cause Notice was issued vide letter dtd. 16.03.2015. AND WHEREAS, you have submitted reply to the Show Cause Notice issued by the Board vide under reference no. 8.


AND WHEREAS, SRO Sangli vide e-mail dtd. 29.01.2016 submitted verification report of Show Cause Notice.

AND WHEREAS your application was resubmitted before Consent Appraisal Committee meeting held on 22.03.2016, to issue final Refusal of Renewal of Consent to Operate to 75 KLPD molasses base distillery due to following non-compliances -

1. Industry failed to scrap the kaccha lagoons in-spite of direction issued by the Board from time to time.
2. Industry failed to submit time bound program with bar chart to Sub-Regional/Regional Office to scrap the kaccha lagoons.
3. Industry failed to provide compost yard for the disposal of spent wash as per CREP norms.

In view of the above, your application for grant of Renewal of Consent to Operate is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refused order.
