
With reference to above subject, this office has received your application for Consent to Establish under Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Authorization under Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008, for development of residential project at Gat No. 1300/1, 1301/3&4, 1301/2, Shikrapur, Taluka Shirur, Dist. Pune

AND WHEREAS, it has been observed that you have started construction without obtaining consent to establish form Board & Environment clearance from competent authority as construction work of 34 buildings out of 38 building completed.

AND WHEREAS, your application for consent to establish was discussed in the Consent Committee Meeting of the Board held on dated 29/04/2016 during discussion it was decided to issue final refusal of consent to establish, as Project proponent has completed construction work of 34 buildings and has failed to submit reply to Show cause notice issued by Board dated 01/10/2015 for starting construction work without C to E from Board.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981. THEREFORE, you are hereby directed to stop construction work at the aforesaid site till further orders.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
