
We refer to application for grant of renewal of Consent to operate for 1250 TCD sugar unit u/s 26 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous & other Wastes (Management and Transboundary Movement) Rules, 2016.

**AND WHEREAS**, it has been decided in consent committee meeting dtd: 03/02/2016 to issue show Cause Notice for refusal of renewal of consent to operate application as you have not obtained consent to establish for additional investment and not up graded of Effluent Treatment Plant **AND WHEREAS** it has been observed from sub-Regional office report vide above ref. at. Sr. (5). You have not paid lapse period fees. You have not submitted clarification on increase in capital investment. The work of Effluent Treatment Plant (ETP) is in process.

**AND WHEREAS**, your application was again discussed in Consent Committee meeting of the Board held on 16/06/2016 and decided to issue final refusal of renewal of consent to operate as industry has fail to submit reply of show cause notice and its compliance; which shows your negligent attitude towards Environment Protection and compliance of consent conditions.

In view of the aforesaid non compliance, your application for grant of renewal of consent is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
