Sub: Refusal of renewal of consent to operate under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention & Control of Pollution) Act, 1981.

WHEREAS, Board has granted consent to operate to your unit with certain terms and conditions which was valid upto 31.01.2016. AND WHEREAS, the following important conditions was prescribed in the consent to comply in time bound manner.

1. Industry shall carryout the treatability study of ETP & performance evaluation of existing air pollution control system from NEERI within three months.
2. Industry shall provide arrangement for treated effluent recycle and reuse at least 50% along with Multiple Effective Evaporator.

AND WHEREAS, you have informed that you are in process of installing MEE to treat RO reject and requested to grant consent vide email dated 04.08.2015.

AND WHEREAS, you have applied for grant of renewal of existing consent to operate with increase in CI of your unit as per the provisions of Section 26 of the Water (Prevention & Control of Pollution) Act, 1974, under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

AND WHEREAS, your case has been discussed in the Consent Appraisal Committee meeting held on 02.06.2016 and it was decided to issue show cause notice for why your application for renewal of consent to operate shall not be refused due to following non-compliances & violation

1. Industry has to provide the arrangement for treated effluent Recycle and Reuse at least 50% along with MEE upto 28.02.2016, but industry failed to comply the same and even not taken any effective steps for the same.
2. Industry failed to carry out the treatability study of ETP & performance evaluation of existing air pollution control system from NEERI on or before 30.11.2015 as per the consent condition no. 10,

AND WHEREAS, the show cause notice was issued vide reference No. (4). AND WHEREAS, you have submitted reply vide reference no 5 above which is not satisfactory.


AND WHEREAS, your case has been again discussed in the CAC meeting held on 08.07.2016 and it was decided to issue final refusal of renewal of consent to operate due to following non-compliances/violations.

1. Industry was granted time period upto 08.12.2015 to carry out treatability study of ETP and performance evaluation of APC system, however you have failed to comply the same till today
2. Industry has informed vide mail dated 04.08.2015 that they are in process of installing MEE to treat RO reject and requested to grant consent. Industry was granted time period upto 28.02.2016 to provide arrangement for 50% recycle of treated trade effluent in process by providing Multiple Effective Evaporator, however they have failed to install the same till today.

AND WHEREAS, industry has failed to comply condition no. 1 & 2 above till today, in spite of assurance given by them and violated the provisions of Water (Prevention & Control of Pollution) Act, 1974.

In view of above, your application for grant of renewal of consent to operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974, under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by the Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refusal order.
