WHEREAS, you have made an application for grant of renewal of Consent to operate u/s 26 of the Water (Prevention & Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention & Control of Pollution) Act, 1981 and an Authorization under Rule 5 of the Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008,

AND WHEREAS, Your case was discussed in the consent committee meeting held on 20.07.2016. In this meeting, it was decided to grant renewal of consent to operate up to 31.12.2019 by imposing conditions, 1] industry shall submit bank guarantee of Rs.5.0 Lakhs in the Board towards operation and maintenance of pollution control systems and consent shall be submitted after obtaining requisite consent fees and bank guarantee within 15 days.



AND WHEREAS, The decision of consent committee meeting was communicated to industry. Industry has submitted request letter in the Board dated 13.09.2016 requesting that to consider consent validity period for the 3 years period and give a time for submission of BG up to 31.03.2017. In this context, Board has regretted request of submission of BG up to 31.03.2017. This decision was communicated to the industry by post and E-mail on 09.01.2017. Further Board has not received any information from the industry about submission of BG. It shows industry is reluctant for submission of BG and not act with accordance to decision of consent committee of the Board.

In view of above, your application for grant of renewal of Consent to operate is hereby **refused** under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundry Movement) Rules, 2008.
