This office is in receipt of your application for renewal of Consent to operate for manufacturing of "Potato Chips & Extruded Products" vide under ref. no.1, and another application for 1st consent to operate for manufacturing of "Waste Derived Fuel" vide under ref. no.2, under section 26 of the Water (Prevention and Control of Pollution) Act, 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Waste (Management, Handling & Transboundry Movement) Rules, 2008.

AND WHEREAS, you were under an obligation to provide ETP treatment plant & disposal arrangement to industrial effluent generation to meet the standards prescribed by the Board in the consent order.

AND WHEREAS, the case of the industry was re-discussed in consent committee meeting dated 03.03.2017 & not approved renewal of consent to operate. It was decided to issue final refusal of renewal of consent to operate and closure directions for following non compliances:

i) Industry has not submitted performance about recycling of 100% treated effluent.

ii) Project Proponent shall come up with better proposal about recycle/reuse of treated effluent as excess hydraulic load is not feasible in the area.

In view of the above, your application for grant of consent to operate/renewal is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Waste (MH& TM) Rules, 2008. If you are aggrieved by this order, you may prefer on appeal as per provision in the Water (P & CP) Act 1974 & the Air (P & CP) Act, 1981, within 30 days time from the date of receipt of this letter.
