The Minutes of the meeting held on 25.11.2019, at 03.00 PM, MPCB, HQ, Sion-Mumbai under Chairmanship of Member Secretary, MPCB for Review implementation of Hon'ble NGT order in O.A.1038/2019 with regard to Comprehensive Environment Pollution Index of MAHAD, Maharashtra

Maharashtra Pollution Control Board (MPCB) conducted meeting under the Chairmanship of Member Secretary to review implementation progress of CEPI- Mahad region in accordance with CPCB conduct comprehensive Pollution Index and listed Mahad under Other polluted areas & compliance of Hon'ble NGT order in OA 1038/2018. List of participants who attended the meeting is attached herewith.

The meeting started with welcome note by Joint Director, APC followed with brief presentation on CEPI action plan and its implementation points. JD APC briefed about the background of CEPI and efforts taken by MPCB for improvement of CEPI areas. Member Secretary, MPCB has taken review with concerned stakeholders for the implementation of action points.

After detailed discussion in the meeting following actions are decided:

- Industry shall use clean fuel.
- 2. Existing units using coal based fuel shall switch over to gas based fuel on priority.
- Industry shall achieve zero liquid discharge, submit environmental status report, increase tree plantation from existing 33% to 40%, compliance of EC conditions, etc.
- 4. Industry shall comply with the latest Hon'ble NGT order dtd. 14.11.2019.
- MPCB shall identify non complying units under Red and Orange categories and submit the action taken report immediately.
- MPCB shall prepare proper inventory of air polluting industries and verify adequacy of pollution control equipment.
- 7. MIDC shall provide new disposal pipeline for CETP treated effluent.
- 8. MIDC shall provide road expansion in the industrial areas.
- MIDC shall take follow-up with Mahad Municipal Council for installation of STP. Subsequent meeting will be scheduled within 7 days for reviewing the progress of STP installation.
- 10. MPCB will finalize CAAQMS station in Mahad within next 3-4 months.
- 11. Regional Officer/Sub-regional Officer will assess installation of STP in Birwadi Gampanchayat under CSR activity form Large industries within 1 Month.
- 12. Regional Officer (HQ), MPCB shall conduct meeting with Municipal Council, Mahad regarding STP. The Member secretary directed to all concerned stakeholders to take appropriate actions in compliance of Hon'ble NGT order and communicate action taken report to MPCB. The details of actions and stakeholders are identified as below:
