
The terms of reference for the Sub-Group are as under -

- (1) The Sub-Group will decide the category of incinerators used for non-bio medical animal anatomical waste such as dead animals i.e. dogs, pigs, chicken, rats etc.
- (2) The Sub-Group will decide about the applicability of Locational Criteria as per RR7/OR2 Regulations
- (3) The Sub-Group will decide about the specifications of incinerators.

(4) The Sub Group will decide whether consent to establish and operate shall be made applicable to such facilities.

(5) The Sub-Group will decide about the delegation of powers for grant of such incinerators.

The Committee will give its report on or before 31st August, 2014 for taking decision about grant of consent.
