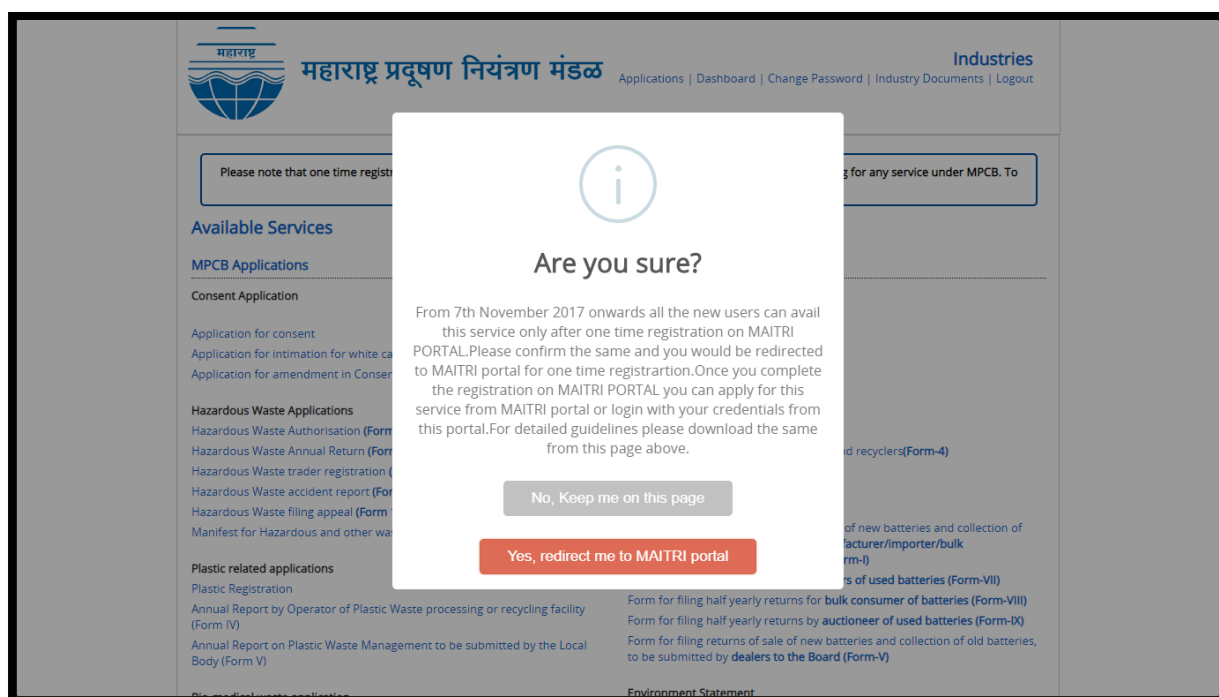


Procedure for Registration for Recyclers, Manufacturers, PIBOs under Plastic Waste Management Rules, 2016 and amendment thereto.


The terms Recyclers, Manufacturers, Producers/ Importers/ Brand-Owners and others used in this document are same as defined in the Plastic Waste Management Rules, 2016 and amendment thereto.



The rule 13 of the Plastic Waste Management Rules, 2016 and amendment thereto provides that Recyclers, Manufacturers, Producers/ Importers/ Brand-Owners (PIBOs) shall obtain registration from State Pollution Control Board or Central Pollution Control Board (as may the case be).

The first step for all the above stakeholders is to create Industry Registration ID with Maharashtra Pollution Control Board through MAITRI (Single Window)

The provisions of Registration under Plastic Waste Management Rules, 2016 and the application form and online portal provided by MPCB are as below:

Recyclers:



“13(3) - Every person recycling or processing waste or proposing to recycle or process plastic waste shall make an application to the State Pollution Control Board or the Pollution Control Committee, for grant of registration or renewal of registration for the recycling unit, in Form II.



13(5)- The State Pollution Control Board or the Pollution Control Committee shall not issue or renew registration to plastic waste recycling or processing units unless the unit possesses a valid consent under the Water (Prevention and Control of Pollution) Act, 1974 (6 of 1974) and the Air (Prevention and Control of Pollution) Act, 1981 (14 of 1981) along with a certificate of registration issued by the District Industries Centre or any other Government agency authorised in this regard.

13(7)- On receipt of the application complete in all respects for the registration for recycling or processing of plastic waste under sub-rule (3), the State Pollution Control Board may, after such inquiry as it considers necessary and on being satisfied that the applicant possesses appropriate facilities, technical capabilities and equipment to handle plastic waste safely, may grant registration to the applicant on fulfilment of the conditions as may be laid down in terms of registration.”


“13(1)- No person shall manufacture carry bags or recycle plastic bags or multi-layered packaging unless the person has obtained a registration from the State Pollution Control Board or the Pollution Control Committee of the Union Territory concerned, as the case may be, prior to the commencement of production.

13(2)- Every producer or brand-owner shall, for the purpose of registration or for renewal of registration, make an application in Form-I to


- i) “The concerned State Pollution Control Board or Pollution Control Committee of the Union territory, if operating one or two States or Union Territories”; or
- ii) “The Central Pollution Control Board, if operating in more than two States or Union Territories”.

13(6)- The State Pollution Control Board or the Pollution Control Committee shall not renew registration of producer unless the producer possesses and action plan endorsed by the Secretary in charge of Urban Development of the concerned State or Union Territory for setting of plastic waste management system”

Issuance/ Cancellation of Registration Application:

“13 (8)- Every State Pollution Control Board or Pollution Control Committee shall take a decision on the grant of registration within ninety days of receipt of an application which is complete in all respects.

13 (10)- State Pollution Control Board or the Pollution Control Committees shall not revoke, suspend or cancel registration without providing the opportunity of a hearing to the producer or person engaged in recycling or processing of plastic wastes”


All applications are disposed according to the decision taken by the Committee constituted for deciding Guidelines for issuance for Registration to Producer /Recycler/ Manufacturer/ Brand Owner in its meeting held from time to time.

In case of any discrepancy, MPCB shall communicate the same through the industry documents section, hence applicants are advised to periodically check their Industry Documents section as shown below:
