Meeting of the stakeholders of CEPI area for Aurangabad including MIDC Waluj , Shendra, Chikalthana, MIDC Railway Station Road and Paithan Road was conducted under the Chairmanship Hon'ble Member Secretary of the MPC Board at Conference Hall, 4th Floor, MPC Board Head Offfice, Sion, Mumbai-22. Dr. V. M. Motghare, Joint Director (APC) introduced the purpose of meeting. He gave audio visual presentation regarding directions of Hon'ble NGT & responsibility of stakeholders to comply with the same so as to bring down the CEPI of Aurangabad by way of abatement of pollution. He informed that in the Application No. 1038/2018, directions are given by Hon'ble NGT regarding CEPI score for Aurangabad as its rank is 39 as polluted area also briefed seriousness of Hon'ble NGT order.
