Central Pollution Control Board (CPCB) has identified certain areas of Chandrapur District as Critically Polluted Areas in Maharashtra and accordingly, action plan for control of pollution in these areas have been prepared by Maharashtra Pollution Control Board (MPCB) after discussions with the stake holders as per the CPCB guidelines.

This action plan has already been circulated to all the stake holders and is also available on MPCB website (www.mpcb.gov.in).

Ministry of Environment and Forests, GoI and CPCB have emphasized the need of effective monitoring and evaluation of various actions proposed under Comprehensive Environmental Pollution Index (CEPI) action plan. The action plan envisages initiative of various stake holders including Govt. and Industrial Sectors and therefore, it is necessary to develop the monitoring mechanism for the effective and timely implementation of the action plan. Considering above Secretary, Environment and Chairperson, MPCB, Mumbai vide letter under reference has directed to form Monitoring Committee under the Chairmanship of District Collector.

In view of above, the following committee is constituted:


