With reference to the proposal Submitted by you vide refer.2 above for preparation of Maharashtra Taluka wise Basin Map Generation, it is to inform you that your proposal dated 20.02.2014 is accepted by MPCB for carrying the work of preparation & generation of "Maharashtra Taluka wise River map for rivers notified in RRZ policy, GoM 2009" as per terms and conditions mentioned here bellow:

1. Aim:

To generate & prepare the "Maharashtra Taluka wise River Map for rivers notified in RRZ policy, GoM 2009" as per the Terms of References.

2. Objectives:

1. Acquire Maharashtra Taluka boundary map of census 2011.
2. Superimpose Basins and Rivers of Maharashtra as per RRZ policy, GoM, 2009 over Maharashtra Taluka boundary map
3. Extract Taluka wise Rivers and Basins as per RRZ policy, 2009 (355 Taluka * Rivers) and (355 taluka *Basins) and create individual layers in GRAM++ Vector file format
4. Prepare images for each of the layers prepared and print on A1 size paper

3. Methodology:

(i) Acquire Maharashtra Taluka boundary map.

The Taluka map as per Census 2011 for the state of Maharashtra will be procured from Census department. If the map is available in soft copy form it shall be acquired and the necessary charges as per actual will be borne by MPCB else the Hard copy map shall be taken and digitized by Bhugol GIS Pvt Ltd.

(ii) Superimpose Basins and Rivers of Maharashtra over Taluka boundary map Basin maps of Maharashtra in GRAM++ Vec file format and Census 2011 Taluka boundary map of Maharashtra will be superimposed using suitable GIS techniques such that the Basin the Maharashtra Taluka boundary superimpose accurately one over other (Necessary correction and adjustment will be applied while mosaicing various Basins and superimposing them over Taluka Boundary map.

(iii) Extract Taluka wise Rivers and Basins (355 Taluka * Rivers) and (355 taluka * Basins) and create individual layers Using GIS techniques Taluka wise Rivers and Basins of Maharashtra notified under RRZ Policy, GoM 2009, will be extracted and individual layers and files of Taluka with River and Basin layer will be prepared..

(iv) Prepare images for each of the layers prepared and print on A1 size paper Based on various layer and files prepared after extracting the Taluka wise River and Basins of Maharashtra, Maps for each layer appropriate as per the scale of the paper size A1 will be prepared. All necessary cartographic elements will be marked and will be printed to create as booklet of images of size A1. The map prepared will also be provided in the soft copy form along with the layers of Maharashtra Taluka wise Rivers and Basins as per RRZ Policy, 2009, GoM.

4. Project Duration:

Time period for completion of above task is 20 days from date of issue of work order.

5. Cost of the Project:

Total Project Cost is Rs 7,97,756/- including service tax.

iv) 3 Licenses of GRAM++ GIS Software

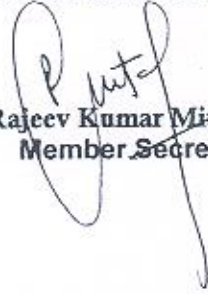
8. Interpretation:
