Sir,

With reference to above captioned subject matter, MPC Board intends to carry out assessment of pollution load in the Mithi River by taking extensive survey of areas & profiling of Mithi river including identification of water pollution sources. The TOR indicating scope of work was communicated to you vide above referred letter cited at sr. No.1. This office is in receipt of your offer letter cited at sr. no.2 & noted that you are ready to work as per TOR issued by this office.

The offer letter submitted by you was discussed in technical evaluation committee of the Board in its meeting held on 18/3/2014 in the chamber of Joint Director (WPC), MPC Board, Sion Mumbai. After discussions, it was decided to award work of Comprehensive study/ profiling of Mithi river stretch to you subject to following terms & condition.

**Terms & Conditions**

1. The work is awarded for comprehensive survey & profiling of river Mithi including preparation of report as per the TOR issued by this office vide above referred letter.
2. You shall adopt standard methodologies for collection of water samples as prescribed by CPCB. The logistic support including equipments /instruments, glass wares, hand gloves etc shall be made available as per required standard protocols. The samples of water collected shall be sent to MoEF approved Laboratory for analysis purposes. Separate work order for the said work will be issued by this office in due course of time.

3. You shall carry out extensive survey of the Mithi River catchment so as to identify major sources of pollution & stretches of waste meeting with Mithi River. You shall complete the work of Comprehensive study / profiling of Mithi river stretch within period 3 months from date of receipt of this work order. The compiled report indicating Domestic & Industrial Pollution load with your expert recommendations regarding abatement of the same shall be submitted to this office by July 15, 2014.
4. The data and information contained in the report shall be treated as a confidential and sole property of MPCB. It shall not be disclosed or published any where without permission of the Board.
5. MPC Board will not provide any additional funds on account of cost escalation due to delay in project implementation or due to any other unforeseen acts.
6. The comprehensive report prepared by you shall be presented in front of Technical Evaluation Committee of the Board.
7. You had submitted offer letter indicating cost of work Rs. 7,86,500/- ( Rupees seven lacs eighty six thousand five hundred only) including taxes. It had been decided in the meeting of Technical Evaluation Committee of the Board to release sum of Rs. 4,00,000/- (Rupees Four lakhs only) as a advance payment. The final payment of the said work will be released after completion of work & satisfactory presentation in front of Technical Evaluation Committee of the Board.
