Your quotation dated 11-05-2014 submitted to MPCB of Rs. 4.50 Lakh plus service tax as applicable (Rs. Four lakh and fifty thousand plus service tax as applicable) regarding preparation of strategic paper on Water Quality Monitoring Network for MPCB has been accepted by the Board and the Board is pleased to issue the work order for "Preparation of strategic paper on Water Quality Monitoring Network for MPCB" with following Scope and Terms & conditions:

1. Scope of work :

- 1.1 Review good practices and norms followed in other SPCBs, other countries (notably UK, EU and United States of America) on water quality monitoring.
- 1.2. Assess the adequacy of present water quality monitoring network of MPCB in terms of locations, parameters and frequency.
- 1.3. Come up with gaps and required strengthening measures based on analyses of water quality data (using TERI report of 2014), norms, good practices and relevance.
- 1.4. Identify strategies and alternatives (with pros and cons) to address the gaps.
- 1.5. Prepare a road map on this basis for consideration of MPCB.
- 1.6. Present this Road Map in a half day workshop at MPCB and finalize the Strategy Paper on this basis.

2. Time frame

- 2.1 You shall submit draft strategy paper on Water Quality Monitoring Network (soft copy on a CD and 5 hard copies in colour) within a period of six weeks from the date of issuance of this workorder.
- 2.2 The final strategy paper (soft copy on a CD and 5 hard copies in colour) shall be submitted within fifteen days period from the date of approval to draft strategy paper.

3. Terms of payment


- a. 20% of the total cost of the project will be paid within 15 days of acceptance of the work order.
- b. 50% of the total cost of the project will be paid after submission of draft report.
- c. Remaining 30% of the total cost of the project will be paid after submission of final report.
