The Project Proponent has applied to the Maharashtra Pollution Control Board for conducting the environmental public hearing for proposed project of molasses-based distillery of 30 KLD. As per the said Notification, one month advance public notice was published in the local newspapers in "Daily Sakal" for Marathi and in national newspaper "The Times of India" for English on 09th July 2021. The public were appealed to send their suggestions or objections regarding the project.

The Convener further informed that, the aim of conducting public hearing is to make aware local people who can be participated in the hearing and they should know the activity to be carried out in the proposed project of molasses based distillery of 30 KLD in respect of M/s.
